Verification

Your application for Federal aid was selected for review in a process called Verification. In this process, the school will be comparing information from your application with signed copies of your and your parents' (or spouse's) 2007 Federal tax forms, or with W-2 forms or other financial documents. The law says we have the right to ask you for this information before awarding Federal aid.

The school must review the requested information, under the financial aid program rules (CFR Title 34, Part 668). If there are differences between your application and your documents, Union's Office of Student Financial Planning will submit corrections for you.

What you should do

1. Collect your and your parents' (or spouse's) financial documents (signed Federal income tax returns, W-2 forms, etc.)
2. Talk to any of the Student Financial Planning staff at Union University if you have questions about completing this form.
3. Complete the form and affix required signatures.
4. Send this form, tax forms, and any other documents the school requests to Student Financial Planning at Union University, 1050 Union University Dr, Jackson, TN 38305.
5. A Union Financial Aid Officer will compare information on the documents with the information submitted on your FAFSA and make any corrections needed electronically.
