DAY 1, Thu, Sep 24

MAINLAND/ HONOLULU

We fly from the mainland to Honolulu where we are met with the traditional fresh flower lei on arrival and assisted to baggage claim. From there we will be directed to our waiting coach. We transfer to our hotel, the *Sheraton Princess Kaiulani*, with the remainder of the day at leisure. (meals aloft)

DAY 2, Fri, Sep 25 OAHU SEMICIRCLE ISLAND TOUR

Today we tour the North Shore, including picturesque Waimea Bay, a legendary surfing spot referenced in the Beach Boys' song "Surfin' U.S.A."; Sunset Beach, where international surfing competitions are often held; and the charming old plantation town of Haliewa. We visit Dole Plantation with free time for shopping and exploring on our own. This afternoon we return to our hotel with some time to relax. Then this evening we attend a memorable luau, enjoying the colorful entertainment and ceremonies as we feast on a buffet of authentic Hawaiian cuisine. Following the luau we return to our hotel. (D)

DAY 3, Sat, Sep 26

HONOLULU

This morning we have a Honolulu city tour, highlighted by a drive through Punchbowl National Cemetery of the Pacific. Following our tour we transfer to Aloha Tower Pier to board the *Pride of America* and acquaint ourselves with the facilities we will enjoy for the next seven days! We settle in to our comfortable cabins and unpack for the week, sailing about 7 p.m. (D)

DAY 4, Sun, Sep 27

KAHULUI, MAUI

Maui is known as the "Valley Island," where every gorge is filled with lush foliage and abundant plant life. A surplus of natural splendor and the genuine hospitality of its people have helped to make Maui Hawaii's second most popular island. Today is yours for independent touring or participating in optional shore excursions of your choice. Explore the fascinating history of the town of Lahaina. Picnic at a nearby plantation, plant yourself on a pristine beach or play one of the world's most beautiful golf courses. (B,L,D)

DAY 5, Mon, Sep 28

KAHULUI, MAUI

You may choose to take a scenic journey through upcountry Maui to the top of the world's largest dormant volcano, Haleakala, from where you enjoy marvelous views over 10,000 feet above sea level. Or, try your hand at snorkeling at Molokini, declared a marine preserve and one of the

top ten snorkel sites in the world. Take part in an exclusive guided reef tour led by marine naturalists and explore this home to more than 250 species of fish. (B,L,D)

DAY 6, Tue, Sep 29

HILO, HAWAI'I

Gaze up from this charming town and see snow-capped Mauna Kea volcano. It's just one of the scenic marvels in this exotic greenhouse of lush tropical plants, towering banyan trees, thundering falls and enough flowers to fill a rainbow. Arid deserts, steaming fissures and volcanoes that blow their tops are just as impressive. This evening, conditions permitting, sail by active Mount Kilauea to see this volcano's lava tumbling into the sea. (B,L,D)

DAY 7, Wed, Sep 30

KONA, HAWAI'I

King Kamehameha. Captain James Cook. The Fire Goddess Pele. The stuff legends are made of - and the island of Hawai'i is just that legendary. The entire island is home to countless places that escape comprehension: Kilauea, one of the world's most active volcanoes; tropical rainforests; lava deserts; towering mountains; beaches of white, green and black; and waterfalls careening through vibrant valleys of color. The real challenge is deciding what to do first! (B,L,D)

DAY 8, Thu, Oct 1

NAWILIWILI, KAUAI

For decades Hollywood has had a love affair with Kauai, and you'll understand why as you discover a land of contrast so diverse it defies belief. You may choose to participate on an optional shore excursion consisting of an action-packed Hawaiian Hollywood odyssey. You'll explore some of the most romantic, exciting and adventurous movie locations in the world and be enlightened with the rich history of the island. This unique live narrated tour with specially licensed video scenes from the various movies make this a must do activity in Kauai. DAY 9, Fri, Oct 2

NAWILIWILI, KAUAI

Enjoy the morning at leisure on Kauai - today you may choose an optional excursion to Waimea Canyon. Discover this breathtaking gorge in the heart of Kauai, often called the 'Grand Canyon of the Pacific.' This magnificent canyon in the heart of Kauai is 10 miles long, one mile wide and 3,400 feet deep, with a spectacular array of rainbow colors created by the reds and browns of exposed volcanic rock, mingled with the blues and greens of lush tropical vegetation. This afternoon we set sail for Honolulu. (B,L,D)

DAY 10, Sat, Oct 3 HONOLULU/DEPART HAWAII

We arrive back in the port of Honolulu this morning. After we disembark, we visit the *U.S.S. Arizona* Memorial Visitor Center. At the Visitor Center, we will experience a 20-minute film presentation about the attack on Pearl Harbor on December 7, 1941. We are then shuttled by boat to the *U.S.S. Arizona* Memorial where we may board and spend some time in quiet reflection. This afternoon we are transferred to the airport for our overnight flight to the mainland.

DAY 11, Sun, Oct 4 RETURN MAINLAND

We arrive back on the mainland this morning and continue home.

TERMS AND CONDITIONS

NOT INCLUDED IN CRUISETOUR PRICE: Transportation between point of origin in the U.S. and Memphis (if not using complimentary transfers between Union University and Memphis airport); checked baggage fee; gratuities (\$20 to guides and drivers; plus cruise gratuities of approximately \$12 per person per day charged to shipboard account); shore excursions; any fuel surcharge imposed by the airline or cruise line; cabin upgrades on cruise; single supplement; excess baggage and forwarding of baggage; meals not listed as being included; after lunch and dinner beverages; items of a personal nature such as laundry; travel protection plan and any item not herein listed as being included.

AIR ARRANGEMENTS: Economy class from Memphis, applicable on Delta, United or any IATA carrier. Air taxes/fuel surcharges of approximately \$100 are included in the cruisetour rate and are subject to any change that may be imposed prior to departure). **Supplement may apply for departure from cities other than Memphis. Please note that specific air seat requests will be forwarded to the airline on your behalf but are subject to final approval/confirmation by the airline.**

TRAVEL DOCUMENTS: A passport is not required for U.S. citizens traveling from the mainland to Hawaii. A valid government-issued photo ID, such as a driver's license, will be required to check in for your flight.

BAGGAGE ALLOWANCE: Due to space limitations on buses used, we have included portage for only one check-on bag (combination width, length and height not to exceed 62 inches and maximum weight of 50 pounds) in tour cost. You may also take one carry-on that will fit under your airline seat or in the overhead compartment.

HONOLULU HOTEL: Four-star/first-class. Portage of one bag per person included. **While Dehoney Travel will try to match roommates, we cannot guarantee a roommate will be available.** In this case, the payment of single supplement will be required. Supplement amount depends upon cruise cabin category. Contact Dehoney Travel for further information.

MEALS & SIGHTSEEING: Meals as listed in itinerary (B = breakfast; L = lunch; D = dinner). Honolulu sightseeing included as described in itinerary. Tour manager to escort the group in Honolulu, plus government-licensed local guides and transfer assistance where required. **Shore excursions are not included in the cruisetour price. Gratuities to your guides, drivers, cruise staff, etc. are not included in the tour rate.**

DEVIATION ITINERARY: Any adjustment in standardized air or land itinerary will carry a \$100 fee (for each change) in addition to any additional expense required. This fee is applicable for research projected and/or accepted. In an effort to ensure efficient handling of these requests, **Dehoney Travel, Inc. requires that a tour deposit be received before a deviation request can be processed. If deviating from the group tour program, there will be no refund for any service not used.**



PAYMENT: Payment can be made by cash, check or credit card (Discover, MasterCard or Visa). **A deposit of \$500 per person** is required at the time of booking. **Final payment is due June 30, 2015. Enrollment in and payment of deposit constitutes your acceptance of the Tour Conditions described herein.**

CANCELLATION: In event of cancellation, there will be a fee of \$100 for Dehoney Travel, Inc. to cover administrative costs. **In addition, without protection as outlined on the following page, cancellation fees will be charged.** Cancellation penalties per person are as follows: up to 120 days prior to tour, \$100; 119-81 days prior to tour, \$500; 80-61 days prior to tour, 50% of total tour cost; 60-31 days prior to tour, 75% of total tour cost; 30 days prior to tour-day of departure/no show, entire tour cost is non-refundable. **All cancellation notifications must be made in writing to Dehoney Travel, Inc. Please allow 4 weeks for cancellation refund processing.**

After ticketing of air fare, a cancellation penalty of 100% of the air fare is in effect. On or after the date of departure there can be no refund for any service not used.

TRAVEL PROTECTION PLAN: As many U.S. health carriers do not provide benefits while outside the mainland and cancellation penalties can be substantial for many tours, Dehoney Travel, Inc. offers a Travel Protection Plan, TripCare, through Allianz Global Assistance. **The Option to Waive Pre-existing Conditions Exclusion requires purchase of Travel Protection within 14 days of deposit. You may decline the Travel Protection Plan, but a signed disclaimer is required and all charges for cancellation or medical treatment/transport while traveling are your responsibility.**

CANCELLATION, DELAY OR DEVIATION OF CRUISE: Carrier may at any time, without notice, delay, change or cancel the cruise or Commencement date, deny Passenger a stateroom or substitute vessels, even if Passenger has a confirmed or guaranteed reservation, and Passenger shall have no claim against Carrier/Dehoney Travel, Inc. for any resulting hotel, food, travel or other expenses, delay, inconvenience or damages whatsoever, other than reimbursement of unearned cruise/vacation package fare. This reimbursement discharges Carrier/DTI from all liability. If, after sailing, the cruise is interrupted by a fortuitous event, Act of God or any other cause for which neither the Carrier/Dehoney Travel, Inc. nor the Passenger is responsible, or the ship is or will be unduly delayed or prevented from proceeding in the ordinary course, Carrier shall have the right to terminate the ship's cruise, and refund the unearned cruise/vacation package fare. In all such cases, unless otherwise stated herein, the Passenger shall not be entitled to any refund of fare or compensation of any kind and shall have no other claim against the Carrier/Dehoney Travel, Inc. In all situations the ship may tow and assist vessels and deviate from the advertised route and call on or omit calling on any port or place for any reason or purpose which, in the Carrier's judgment, is reasonable under existing circumstances, and to comply with all orders given by governmental authorities, the underwriters of the ship or the Carrier. Passenger shall have no claim whatsoever against Carrier/Dehoney Travel, Inc. in such circumstances.
