## Tennessee Department of Children's Services Title IV-E Tuition Assistance Program

- Provides full-time undergraduate students with tuition and financial assistance for up to four semesters.
- DCS pays Title IV-E graduates a higher starting salary.
- In return, participants must work for DCS for 18 to 24 months (depending upon the amount of funding they receive) as a frontline case manager when they graduate.

#### **Application Deadlines:**

Fall Semester – June 15 Spring Semester – November 15.

Failure to fully complete and submit application materials by the deadlines listed could result in disqualification or delays to your admittance to the Program.

#### To be Eligible for Participation You Must:

- Be a U.S citizen or eligible to work in the U.S.
- Undergo a background check and fingerprinting.
- Be admitted into an accredited social work program at a participating university and have at least a 2.6 GPA in social work courses.
- Have no more than four semesters remaining before graduating.
- Commit to work as a front-line case manager with DCS immediately upon graduation.

# What DCS staff say about being a Child Welfare Case Manager

### What is it like to be a Child Welfare Case Manager?

"A frontline Case Manager is a jack of all trades. I have to navigate employment issues, welfare and insurance, education systems, mental health, law enforcement, court, alcohol and drug issues, housing and family dynamics that impact the children and families I serve daily as well as manage service providers, support staff and administrative policy directives."

### Is being a frontline Case Manager rewarding?

"Being a case worker is rewarding; you get to see the best and worst in people. There are some personality traits that are a benefit to have in this job: flexibility, open-mindedness, the ability to multi-task, good communication skills and liking people. It's not a job for the faint of heart, but then again you wouldn't be a social worker if you were timid!"

### Is being a frontline Case Manager challenging?

"It's challenging all of the time because the decisions we make affect other people's lives."
